



## TERMS & CONDITIONS

### Trade & Buying House – Manufacturer Direct

Abdullah Hurtz Company (Pvt) Ltd. operates strictly as a trade and buying house, sourcing exclusively from verified manufacturers. The Company does not act as a broker, retailer, or open-market trader unless explicitly agreed in writing.

The Company facilitates sourcing, supplier coordination, customization support, quality coordination, export documentation, and shipment management. Manufacturing responsibility remains with the respective manufacturer unless otherwise stated in writing.

#### 3. Pricing

All prices quoted are manufacturer-based and subject to change prior to order confirmation due to raw material cost variations, exchange rate fluctuations, or factory revisions.

#### 4. Payment Terms

Unless otherwise agreed in writing, 100% advance payment applies for Africa and other high-risk or new regions. All bank charges outside Pakistan shall be borne by the buyer.

#### 5. Order Confirmation

Orders are considered confirmed only upon receipt of full payment or confirmed LC and written acknowledgment by the Company.

#### 6. Quality & Specifications

Goods are supplied as per confirmed specifications. Minor variations acceptable under international trade norms shall not be considered defects.

#### 7. Inspection

Third-party inspection may be arranged at the buyer's request and cost. In the absence of inspection instructions, goods shall be deemed accepted upon shipment.

#### 8. Delivery & Shipment

Delivery timelines are estimates and subject to manufacturer production schedules, logistics conditions, and force majeure events.

#### 9. Risk & Title

Risk and title shall transfer in accordance with the agreed Incoterms as mentioned in the quotation or contract.

#### 10. Warranty

Warranty, if any, shall be product-specific and strictly subject to manufacturer policy and terms expressly stated in the contract, purchase order, or quotation. No implied warranties apply. Warranty covers manufacturing defects only and shall be void in cases of misuse, improper installation, modification, mishandling, storage issues, or normal wear and tear.

#### 11. Claims

Any claims must be notified in writing within seven (7) days of receipt of goods and must be supported with proper evidence.

#### 12. Limitation of Liability

The Company's liability, if any, shall be limited to the value of services provided and shall exclude any indirect, incidental, or consequential losses.

#### 13. Confidentiality

All technical, commercial, and pricing information shared shall be treated as confidential and shall not be disclosed without prior written consent.

#### 14. Governing Law & Jurisdiction

These Terms & Conditions shall be governed by and construed in accordance with the laws of Pakistan. Courts of Pakistan shall have exclusive jurisdiction.

#### 15. Sales Office

Sales and coordination office: Dubai, UAE (if applicable / optional).

#### 16. Force Majeure

The Company shall not be liable for delays or failures caused by events beyond its reasonable control, including but not limited to natural disasters, strikes, governmental actions, or logistics disruptions.

#### 17. No Implied Warranties

All implied warranties, including merchantability or fitness for a particular purpose, are expressly disclaimed unless explicitly stated in writing.

#### 18. Limitation of Remedies

Accepted warranty claims shall be limited solely to repair, replacement, or credit, as determined by the manufacturer.

#### 19. Buyer Responsibility & Conduct

The Buyer is responsible for product selection, compliance with local laws and regulations, and proper use of the goods. Any bad-faith, abusive, or misleading claims shall be rejected.

#### 20. Indemnity

The Buyer agrees to indemnify and hold harmless Abdullah Hurtz Company (Pvt) Ltd. from any claims, losses, damages, legal actions, or liabilities arising from misuse, third-party disputes, regulatory non-compliance, or misrepresentation.
